PUBLIC NOTICE - ACCOUNTANCY FIRMS REGISTERED BY THE BOARD

In accordance with the provisions of Section 8(2) of the Accountants and Auditors (Registration) Act, [Cap 286 R.E. 2002], the NBAA Executive Director is required to publish a list of registered accounting firms. The publication made under this provision is evidence that the persons or firms named therein are registered under this Act.

It is therefore an offence under Section 29 to employ any person or a firm who is not registered by the Board.

The general public and Reporting Entities are hereby required to confirm with the NBAA prior to employing such persons in order not to contravene the requirements of the law.
