VIRTUAL AND PHYSICAL CLASSES

The National Board of Accountants and Auditors invites applications for admission into its Diploma in IPSAS course for its 13th intake.

Entry Qualifications:

Holders of Certified Public Accountant (CPA) Certificate or its equivalent or holders of Postgraduate Degree in Accounting, Finance, Tax or related subjects or holders of Certificate in IPSAS.

Targeted learners:

- Accountants and finance staff at all levels who are involved in the preparation of financial statements.
- Trainers wishing to acquire advanced knowledge of the standards.
- IPSAS's implementation and sustainability teams.
- Both Internal and External Auditors and consultants dealing with financial reporting.
- Officers responsible for public sector financial reporting and auditing.

Course is offered in both Virtual (online) and Physical classes.

Physical classes will be held in Dar es Salaam and Dodoma:

Dar es salaam: Three days per week on Mondays, Wednesdays and Fridays. Classes start from **5.00 p.m to 7.00 p.m (2hrs).**

Dodoma : Three days per week on Mondays, Tuesdays and Wednesdays. Classes start from **5.00 p.m to 7.00 p.m (2hrs).**

Online Classes: Three days per week on Mondays, Wednesdays and Fridays. Classes start from **5.00 p.m to 7.00 p.m (2hrs).**

Duration of the Course: 6 months. Classes will begin on **Monday 3rd October 2022.**

Examinations: All examinations will be conducted physically in the following regions provided that there will be more than 20 candidates:

- **Dodoma**
- **Dar es Salaam**
- **Zanzibar**
- **Mwanza**

- *Arusha and*
- *Mbeya*
